ORDER

As per the letter read as 2nd paper above ,the Director of General Education has put forwarded a proposal as a new intervention to provide 25 gm Peanut-Seasame Chikki @Rs.7.50 four days in a week to about 1,79,000 School Children studying in Primary&Upper Primary classes of 895 Schools (Government,Aided &Special schools) for 40 weeks (160 days) enrolled under PM-POSHAN Scheme (Mid Day Meal Scheme) in Idukki,Wayanad Districts and tribal areas of Palakkad District by availing Flexi - Fund facility under the Scheme for the financial year 2022-2023 . The Director has also informed that the Programme Approval Board (PAB) of PM POSHAN that met on 13th May, 2022 to consider the Annual Work Plan and Budget Proposals of the State, has approved the said proposal and granted permission to utilize a maximum of 2148.00 lakh rupees (5% of the approved recurring central and Sate shares for 2022-23) as flexi funds during the year 2022-23 for implementing the intervention and the Central and State shares for the initiative were pegged at 1288.80 and 859.20 lakh rupees respectively.
