1. LOT 32 COMPRISES THE LAND AND REAL PROPERTY WITHIN THE BLUE BORDER OF THIS SUBDIVISION, EXCEPT THEREFROM UNITS 1 THROUGH 31, INCLUSIVE, AS SHOWN AND DESCRIBED.
2. EACH UNIT IS A SUBDIVISION OF AIR SPACE IN A BUILDING BUILT, OR TO BE BUILT AND IS DESIGNATED WITH ONE OF THE FOLLOWING NUMBERS, TO WIT: 1 THROUGH 31 INCLUSIVE. UNITS 1 THROUGH 15, INCLUSIVE, ARE GROUND FLOOR UNITS. UNITS 16 THROUGH 31 ARE SECOND STORY UNITS.
3. SOLID LINES ON SHEETS 3 AND 4 INDICATE INTERIOR FACES OF WALLS OF A BUILDING BUILT, OR TO BE BUILT. THE THICKNESS OF ALL OUTSIDE WALLS IS 0.50 FEET. THE THICKNESS OF ALL COMMON WALLS IS 0.46 FEET.
4. THE BOUNDARIES OF EACH OF THE UNITS SHOWN ON SHEETS 3 AND 4 ARE MEASURED TO THE INTERIOR SURFACES OF THE VERTICAL, HORIZONTAL AND INCLINE PLANES AT THE LIMITS OF THE DIMENSIONS AND ELEVATIONS SHOWN. ALL UNIT BOUNDARIES ARE AT RIGHT ANGLES, OR PARALLEL, UNLESS OTHERWISE NOTED.
5. F.F. AS SHOWN HEREON DENOTES FINISHED FLOOR.
6. U.L. AS SHOWN HEREON DENOTES UPPER LIMITS OF THE INCLUDED UNIT.
