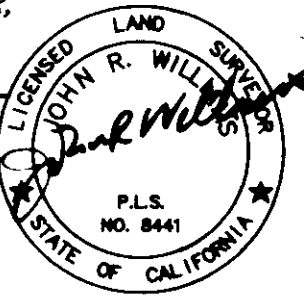

BASIS OF BEARINGS

THE BASIS OF BEARINGS FOR THIS SURVEY IS THE NORTH LINE OF THE NORTHEAST QUARTER OF SECTION 6 SHOWN HEREON AS N 89°57'56" E PER (R1).

SURVEYOR'S NOTE:

THE REASON THIS SURVEY WAS PERFORMED IS DUE TO A DISCREPANCY BETWEEN RECORD OF SURVEY 34-41 (R1) AND RECORD OF SURVEY 34-52 (R2) AND VARIOUS PHYSICAL EVIDENCE OF EARLIER SURVEYS FOUND IN THE FIELD.

1) THE EAST QUARTER CORNER OF SECTION 6 WAS ERRONEOUSLY ESTABLISHED ON (R1). (R2) FOUND A 2" IP SET BY CHARLES W. FULTON, & TWO ORIGINAL USGLO BEARING TREES. THE MONUMENT FOUND ON (R2) IS ACCEPTED AS A PERPETUATION OF THE ORIGINAL MONUMENT PER (R). THIS WILL CHANGE THE POSITIONS OF CORNERS SET PER (R1). NUMEROUS DIMENSIONS FROM (R1) WERE OMITTED ON THIS MAP FOR CLARITY.

2) THIS SURVEY RECOVERED IRON PIPE MONUMENTS AT A MAJORITY OF THE PRIVATE PROPERTY CORNERS. THESE PIPES ARE OF THE CHARACTER SET BY CHARLES W. FULTON, LS 1112, MONO COUNTY SURVEYOR IN THE 1920'S. THESE MONUMENTS ARE PUNCHED WITH THE INITIALS "CWF" AND OTHER ADDITIONAL MARKINGS. IT IS THIS SURVEYOR'S OPINION, THESE MONUMENTS WERE SET BY THE COUNTY SURVEYOR WITH THE AUTHORITY TO DO SO AND ARE THEREFORE ACCEPTED.

3) A CERTAIN RIGHT OF WAY DEED RECORDED MAY 5, 1926 IN BOOK V PAGE 149 OF DEEDS IN THE OFFICE OF THE COUNTY RECORDER CONTAINS A STATEMENT "...AS PER MAP PREPARED BY C.W. FULTON, COUNTY SURVEYOR, OF MONO COUNTY..." IT IS BELIEVED ALL INTERESTED PARTIES WERE AWARE OF THE "FULTON MAP". THIS SURVEY ACCEPTS THE "CWF" MONUMENTS AS THE PROPERTY CORNERS.

4) THIS RECORD OF SURVEY MODIFIES THE LOCATION OF PROPERTY LINES SHOWN ON (R1) PER NOTES ABOVE. THE LOCATION AND ALIGNMENT OF WALKER LAKE ROAD HAS NOT CHANGED AND IS DEPICTED IN THE SAME LOCATION AS SHOWN ON (R1). THIS MAP IS NOT INTENDED TO ALTER ANY RIGHTS ASSOCIATED WITH SAID ROAD.
